



MOBILE ALERTS (NOTICES) WILL BE DELIVERED FROM '84804'

SoCalGas has recently performed an update related to the underlying technology that allows Envoy users to receive notices through mobile devices. Moving forward, Envoy users who have subscribed to receive notices through a mobile device should expect to receive text messages from the number '84804'. For Envoy users who have already subscribed to receive notices through a mobile device, there is no action required on your part. For Envoy users who have not subscribed to receive notices through a mobile device and would like to receive notices through a mobile device, login to Envoy, go to Manage Alerts, then enter the required information.



ENHANCED KEYWORDS SEARCH FOR PUBLIC NOTICES

Envoy users may now use the 'Keywords' search function available within Envoy's 'Notices' pages to search for words within the body of a notice in addition to words within the subject line of a notice.

NEW STORAGE AVAILABLE CAPACITY VS. SCHEDULED SCREEN

A new Envoy screen named 'Storage Available Capacity vs. Scheduled' is now available. This screen displays nomination quantities and scheduled quantities for Net Storage Injection and Net Storage Withdrawal, by Flow Date and by Cycle. The existing screen named 'Available Capacity vs. Scheduled' has been renamed to 'Receipt Point Available Capacity vs. Scheduled' to distinguish the storage-related screen from the receipt point-related screen.
